## 1.0 General

- 1.1 The NABET Accreditation Mark as shown in the Annexure is the property of NABET and its use shall be controlled. Compliance to the guidelines and conditions is required for using NABET Accreditation Mark
- 1.2 Whenever a school is accredited, NABET shall inform the relevant entity about the conditions of the use of Accreditation Mark.
- 1.3 Accreditation Mark can be used by NABET Accredited Schools only.

## 2.0 Guidelines and Conditions of Use of Accreditation Mark

Accreditation mark can be used –

- a) Accredited school can only use the accreditation mark.
- b) Accreditation Mark can be printed as colored image or black and white as indicated in Annexure -I
- c) Accreditation mark shall not be used to suggest any approval or sponsorship of NABET other than the school accredited.
- d) Accreditation mark shall not be used in any way that misleads the reader about the accreditation status of the school
- e) Accreditation mark is not transferable and to be used only by the accredited school as described in its application.
- f) Accredited school upon suspension or withdrawal or expiry of its accreditation ( however determined), shall discontinue the use of NABET Accreditation Mark on all media of communications by the school including promotional material, school letter head, newsletters, brochures, annual reports, business cards and advertisements etc.
- g) NABET reserves the right to change the conditions as and when considered necessary and the same shall be communicated to schools

### **3.0 Verification**

3.1 NABET shall at its discretion carry out a verification of the proper use of the accreditation Mark.

3.2 If any misuse of the accreditation is noticed then NABET shall initiate actions as per procedure for suspension and/or withdrawal of its accreditation.

### **4.0 Records**

4.1 Director NABET shall maintain records pertaining to all misuse of accreditation mark for period depending upon the nature of misuse and action taken. It shall, however, be retained for a period of 5 years.
