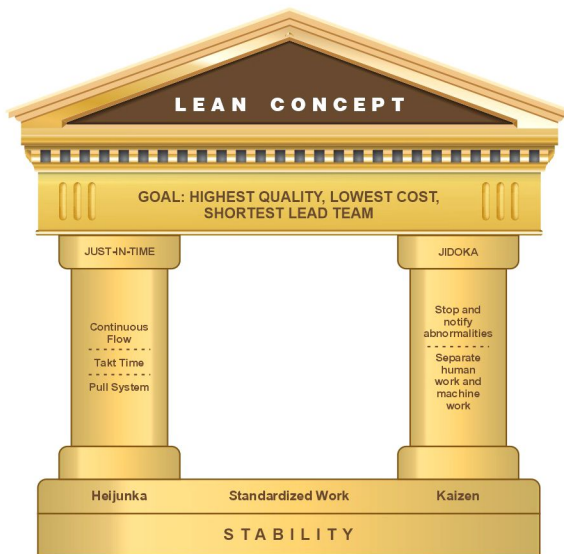
ABOUT LEAN

Lean is an internationally acknowledged process to transform an organization to be competitive and profitable by reducing waste.

LEAN is designed on two basic pillars of production management i.e. Just in Time (JIT) and Jidoka, that provides optimum use of manpower and machines and also helps in identifying & correcting errors at the right time to increase quality, productivity, safety and ultimately profit.

Under LEAN, the production process is balanced by following the Japanese 3M concept of MUDA, MURA, MURI, apart from using many proven tools like 5S, KANBAN, Poke Yoke, Cellular layout etc.

Hence in order to improve the working efficiency and productivity of Indian MSMEs, the Ministry of MSME, Government of India has launched the MSME COMPETITIVE LEAN scheme.

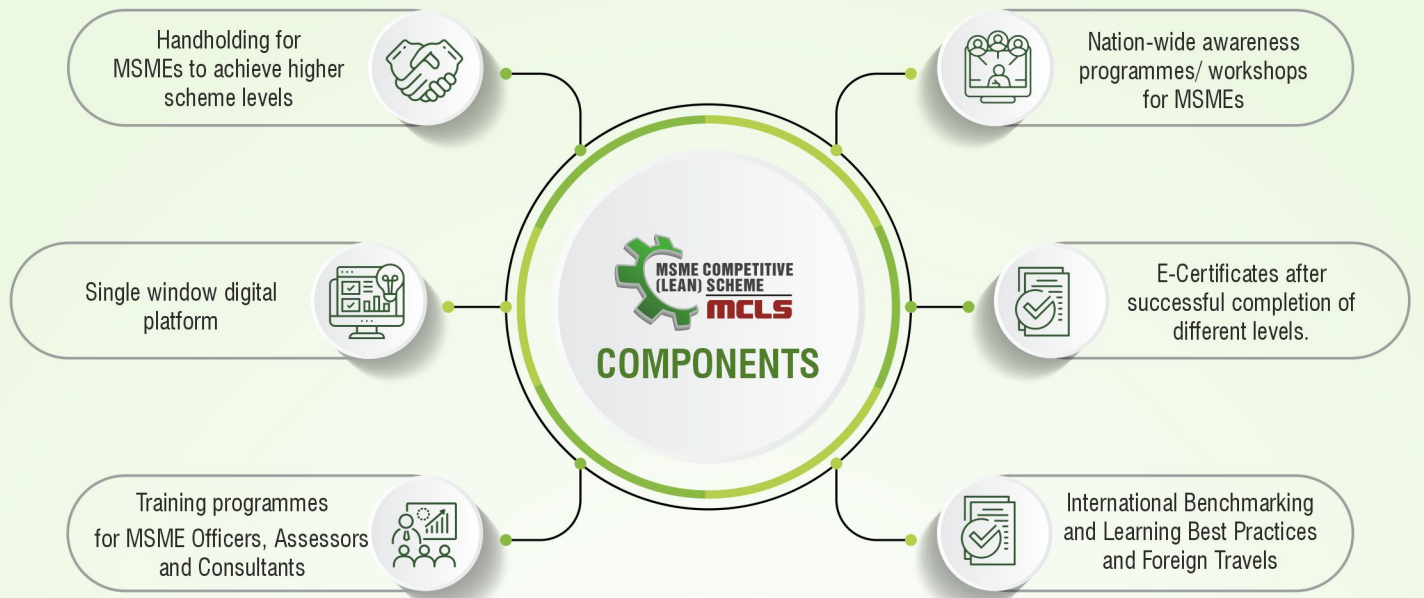

ADDITIONAL INCENTIVES

- ◆ Rs. 5000 per MSME shall be given to OEMs / Associations after completing all stages of lean intervention.
