

# SCHEME FOR ACCREDITATION OF GROUND WATER CONSULTANT ORGANIZATIONS

## EMPANELMENT OF ASSESSORS

National Accreditation Board for Education & Training (NABET), a constituent board of the Quality Council of India (QCI) is operating the accreditation scheme for Ground Water Consultant Organizations. Details of the Scheme are available on the QCI website [www.qcin.org](http://www.qcin.org).

Consultant Organizations seeking accreditation under the Scheme need to meet requirements of having experts with defined qualification and experience to be involved for preparing Hydrogeological Reports, expertise and facilities to collect and interpret baseline data and Quality Management Systems to be followed. Accreditation is given both on the basis of assessment of documents submitted in prescribed formats, interaction with the experts and assessment of facilities and QMS etc. at the premises of the applicant organization.

NABET proposes to empanel Assessors for the Scheme who meet the following requirements of qualification and experience –

### **Qualification:**

- i. Master's (post-graduate) degree in Science/Technology or equivalent in either subject Hydrogeology, Geology/ Applied Geology, Geophysics, Water Resources Management from a UGC/AICTE recognized University/ Institution or equivalent
- ii. Membership of a professional body in her/his area/s of expertise will be an added qualification.

### **Experience:**

- i. Should have minimum 15 years of experience in their professional fields, out of which minimum 8 years should be in Hydrogeological Report preparation field as a consultant/ regulator/ client/ research worker/ teacher/ NGO.
- ii. Desirable hands on experience in ground water modelling and impact assessment, review of Hydrogeological Reports.

**Engagement:** In one month there may be work of 6-9 days, as and when required.

### **Note:**

- The expert should not be involved in any capacity in the process of Preparing Hydrogeological Reports and must submit an undertaking to this effect.
- Candidate must also declare to the Board about association of his/her and/ or immediate family relative/s with any of the Ground Water Consultant Organization that can affect the impartiality of the assessment process.
- No telephone enquiries will be solicited.

Please send a soft copy of your resume in attached format (Sub: Empanelment of Assessors for Accreditation Scheme for Ground Water Consultant Organizations) with a recent passport size photograph and 3 references (with their contact details and your consent to contact them) to C.E.O. NABET. NABET proposes to make a roaster of such applications. These will be processed further on half yearly/yearly as per the requirements.
