2. From July 1, 2017 Organisation is making payment to QCI are requested to add GST charge @ 18% on the fees mentioned. Fees received without GST will not be accepted.

## Guidance notes:

- Application to be submitted along with necessary documents & application fees through online portal (<u>https://feed.qci.org.in/</u>)
- 2. The accreditation fee does not include expenses on outstation travel, lodging/ boarding of assessors, which will be borne by school on actual basis.
- 3. The accreditation, once granted will be valid for four years, subject to continued compliance to accreditation criteria and payment of applicable fees.
- 4. The accreditation fee is payable after accreditation assessment visit.
- 5. 15% discount will be admissible in case school pays the accreditation fee for four years in one instalment.
- 6. The surveillance visit will be planned annual ± one month from date of grant of accreditation.
- 7. NABET may call for un-announced visit, based on any concern or any serious incident.
- 8. For additional visit/s the school shall bear the additional man day fee (as applicable), travel, boarding & lodging expenses (on actual).
- 9. Fees once deposited is non-refundable.
